### I. TERMS & CONDITIONS 参选细则

#### 1. General

- The nominee is an existing leader of key figure in business, researchers from institute, organization, or even a retiree with these background.
- The nomination is open globally, and nominee is required to have min 3 years stay in Asia;
- Nomination can be made directly by the nominator, or by self-nomination;
- The nominee's age must be above 21, and no criminal record in the past.

## 3. Procedure

- The candidate is required to submit the nomination form by the closing date, 31<sup>st</sup> Aug 2024.
- Based on the submitted materials, the judge panel will identify the qualification of nominees. Internal assessment for the nomination will be conducted by judging panel, including candidate interview if appropriately.
- The organizer will send the "Letter of Congratulations" to the candidate if he/she passed the assessment by the judge panel. However, the organiser will withdraw the "Letter" and give the chance to next qualified nominee if the winner is not responding to the "Letter" in 5 working days.
- Finalists will be announced at the award ceremony on 30<sup>th</sup> Oct 2024.

4. must highly value the sustainability with contribution to the country and the society;

#### GROUND-BREAKING SCIENTIST AWARD

2. The candidate has made distinguished academic achievements or owned significant patents; or
3. Having initiated a scientific research project with major theoretical or technological breakthroughs or reaching the world advanced level;
4. Having made outstanding contributions to Asian development through science and tech achievement.

#### INSPIRATIONAL ENGINEER AWARD

1. The candidate has more than 15 years of engineering experience, professional ethic conduct without bad records.
2. The candidate has made distinguished academic achievements or owned significant patents; or
3. Having initiated a remarkable project with major social impact or technological breakthroughs or reaching the world advanced level;
4. Having made outstanding contributions to infrastructure development through innovation and engineering achievement.

#### RESPONSIBLE COMPANIES AWARD

1. Min 3 years of business operation in Asia, with an annual income of more than US\$8 million and has more than 50 full-time employees;
2. The company has a sound management and solid financial performance;
3. The company conducts a good practice in CSR (corporate social responsibility) or ESG (environment, social and governance) in past years. Through the commitment fulfilment in social responsibility, the company has established a track record and gained a good reputation in the industry;
4. The company has proven the value of sustainability to the country and the society through project initiative and programe campaign;

## VISIONARY INVESTMENT COMPANIES AWARD

1. Incorporated in Asia, the company's core business is correlated to investment or finance.
2. The company need at least 3 years operation with sound management, and has made successful cases in past 2 years which can be incubation center, VC, private equity, asset management, home office etc.;
3. The company's projects start with at least US\$1 million, and it has clear investment strategy. The investment is not only focus on return but also meet the trend of sustainability and achieved the "Green" mission to the society.

## PROMISING SME AWARD

1. Incorporated in Singapore, min 2 years of business operation, the group achieve an annual income of more than US\$8 million with less than 200 full-time employees;
2. It should demonstrate steady growth in revenue, market share, or customer base, showcasing significant potential for future expansion.
3. The SME should be able to prove its ability to innovate, either by introducing new products/services or by enhancing existing ones.
4. It should exhibit adaptability to changing market dynamics through product diversification, customer engagement strategies, or operational flexibility.

## ASIA OUTSTANDING WOMEN AWARD

### 亚洲卓越女性奖

1. Eligible for female candidate, and her citizenship in Singapore or Asia countries;
2. She has business incorporated in Singapore or Asia, at least 3 years of finance record with sound management;
3. She should be involved and active in business or professional area;
4. She had excellent capability, practice, vision and leadership to develop business and sustain growth of business;

## ASIA STRONG FAMILY OFFICE AWARD

### 亚洲稳健家办奖

1. The family office, whether single or multi-family, should have at least two years of local operation with sound management practices.
2. The family office should have a distinguished history of sustained financial success across two generations.
3. The office prioritizes philanthropy by actively engaging in impactful charitable endeavours that benefit communities. They should have made cumulative donations of at least \$1 million over the past three years or the equivalent contribution in kind.
4. They prioritize client needs, fostering enduring trust and satisfaction through exceptional service and integrity. The family office should have a rational team structure and a comprehensive family succession plan.
5. The family office should earn recognition and respect from peers and experts for its contributions and best practices in wealth management.

## DISTINGUISHED BANKER AWARD

### 银行家敬业精神奖

1. The candidate plays an important role in the banking institute including bank, insurance, financial service, financial institute which has a sound management and solid business performance;
2. Through his/her leadership, the nominee brings the tremendous growth to the bank or the financial organization he/she served.
