### I. GENERAL 参选细则

#### 1. Terms & Conditions

Today, Fortune Times delivers business news and insights through its magazine, online content, social media channels, conferences, and publications. The e-version of Fortune Times is distributed to more than 20 airlines and 30 international hotel groups, reaching audiences in over 40 countries worldwide.
- 2) Launched in 2015, the **Fortune Times Awards** annually honours excellence in leadership, innovation, and achievement across Asia. The Awards recognise influential figures, visionary leaders, and corporations that have demonstrated exceptional business performance and contributed meaningfully to society.
- 3) All winners are required to attend the award ceremony in person; representatives will not be accepted. For absence due to unavoidable external factors or critical circumstances, it must be approved by the judging panel in advance.
- 4) Award recipients are entitled to use the official award logo and trophy for promotional and publicity purposes in an appropriate manner. All winners are required to take up the official award package priced at **S\$28,000**. This package is non-refundable, non-transferable, and non-withdrawable once the winner has agreed to accept the award.
- 5) If a winner is found to have damaged the reputation of the Fortune Times Awards or infringed the rights of third parties, the organiser reserves the right to revoke the award, including the trophy and certificate, with immediate effect and without compensation.
- 6) All documents submitted will be treated with strict confidentiality and used solely for judging purposes. The organiser is not responsible for the loss or damage of any award-related items, including documents, trophies, or certificates.
- 7) There is no registration or nomination fee for the Fortune Times Awards. Nominations are assessed by an independent judging panel based on the published award criteria.
- 8) All candidates must complete and submit the official nomination form on a voluntary basis, confirming that they have read, understood, and agreed to abide by the award rules and regulations.

## 2. Eligibility

- The nominee is an incumbent leader, key figure in business, researcher from institute, leader of organization, or even a retiree with such background.
- The nominee's age must be above 21, and possess no criminal record in the past.
- The nomination open globally, and nominee is required to have stayed for a min 3 years in Asia.
- Nomination need be made through the member from the panel of judge.

## 3. Procedure

- The nomination starts from noon on 8<sup>th</sup> Aug 2025. The nomination form is available for download from the award websites, [www.FortuneTimes.sg](http://www.FortuneTimes.sg), and [www.NewFortuneTimes.com](http://www.NewFortuneTimes.com)
- The candidate is required to submit the nomination form by the closing date, 30<sup>th</sup> Sep 2025.
- Based on the submitted materials, the judge panel will identify the qualifications of nominees. Internal assessment for the nomination will be conducted by a judging panel, including candidate interview if appropriate.
- The organizer will send the "Letter of Congratulation" to the nominee if he/she passes the assessment by the judge panel. However, the organiser will withdraw the "Letter" and give the chance to the next qualified nominee if the nominee failed to responding to the "Letter" in 5 working days.
- Finalists will be announced at the award ceremony on 22<sup>nd</sup> Oct 2025.



## 4. Third Parties' Rights

#### ASIA EXCELLENT LEADERSHIP/ENTREPRENEUR AWARD

1. The candidate must be a leader, founder, owner or from an equivalent of a C-suite management in the company;
2. Min 3 years business operation in Asia, with an annual income of more than US\$8 million or has more than 50 full-time employees;
3. Under his or her inspiring leadership, the company has made rapid progress and produce good business performance;
4. must highly value sustainability with contributions to the country and the society;

#### GROUND-BREAKING SCIENTIST AWARD

1. The candidate has more than 15 years of R&D experience, and shown professional ethic conduct without bad records.
2. The candidate has made distinguished academic achievements or owns significant patents; or
3. Has initiated a scientific research project that made major theoretical or technological breakthroughs or reached internationally advanced level;
4. Has made outstanding contributions to Asian development through science and tech achievement.

#### INSPIRATIONAL ENGINEER AWARD

##### 启发进步工程师奖

1. The candidate has more than 15 years of engineering experience, professional ethic conduct without bad records.
2. The candidate has made distinguished academic achievements or owned significant patents; or
3. Having initiated a remarkable project with major social impact or technological breakthroughs or reaching the world advanced level;
4. Having made outstanding contributions to infrastructure development through innovation and engineering achievement.

#### RESPONSIBLE COMPANIES AWARD

##### 企业永续责任奖

1. Min 3 years of business operation in Asia, with an annual income of more than US\$8 million and has more than 50 full-time employees;
2. The company has a sound management and produces solid financial performance;
3. The company executed good practice in CSR (corporate social responsibility) or ESG (environment, social and governance) in past years. Through commitment to fulfilling social responsibilities, the company has established a sound track record and gained a good reputation in the industry;
4. The company has proven the value of sustainability to the country and the society through project initiative and campaign;

#### VISIONARY INVESTMENT COMPANIES AWARD

##### 投资远见企业奖

1. Incorporated in Asia, the company's core business is related to investment or finance.
2. The company needs at least 3 years of operation with sound management, and has produced successful entities in past 2 years which can be incubation center, VC, private equity, asset management, home office etc.;
3. The company's projects start with at least US\$1 million, and it has clear investment strategy. The investment does not only focus on return but also meet the trend of sustainability and has achieved the "Green" mission for the benefit of society.

## PROMISING SME AWARD

### 创新潜力中小企业奖

1. Incorporated in Singapore, min 2 years of business operation, the group has achieved an annual income of more than US\$8 million with less than 200 full-time employees;
2. It should demonstrate steady growth in revenue, market share, or customer base, showcasing significant potential for future expansion.
3. The SME should be able to prove its ability to innovate, either by introducing new products/services or by enhancing existing ones.
4. It should exhibit adaptability to changing market dynamics through product diversification, customer engagement strategies, or operational flexibility.

## LEADER IN FINTECH SOLUTIONS AWARD

### 金融科技解决方案领导者奖

1. Eligible for institutes including bank, insurance, financial service and financial institute which have a sound management and shows solid business performance;
2. The institute has achieved the overall good improvement in business, digitalization and CSR, and he/she is committed to pursuing better service experience.
3. Demonstrated innovation in applying fintech technologies—such as AI, blockchain, or big data analytics—to improve operational efficiency, enhance customer engagement, or create new business models.
4. Has proven impact and scalability in fintech solutions, with measurable results in market reach, revenue growth, or positive transformation of the financial ecosystem.

## ASIA STRONG FAMILY OFFICE AWARD

1. The family office, whether single or multi-family, should have at least a record of two years of local operation with sound management practices.
2. The family office should have a distinguished history of sustained financial success across two generations.
3. The office prioritizes social impact investment that benefit communities. They should have made cumulative donations of at least \$1 million over the past three years or equivalent contributions in kind.
4. They prioritize client needs, fostering enduring trust and satisfaction through exceptional service and integrity. The family office should have a rational team structure and a comprehensive family succession plan.
5. The family office should have earned recognition and respect from peers and experts for its contributions and best practices in wealth management.

## ASIA OUTSTANDING WOMEN AWARD

### 亚洲卓越女性奖

1. Eligible for female candidate with citizenship in Singapore or an Asia country;
2. She has a business incorporated in Singapore or Asia, with at least 3 years of finance record showing sound management;
3. She should be involved and active in business or professional area;
4. She has excellent capability, practice, vision and leadership to develop business and sustain business growth;
